In October 2019, Terry and I went to court to present our case for adoption to an Ugandan judge. We were accompanied by Joshua and Grace of course, but also by their grandmother, an aunty, a social-worker and our lawyer.

Our lawyer presented the details of the case and argued how we had fulfilled the requirements of the laws associated with adoption. Of course, he summed up his presentation with our request to be allowed to adopt Joshua and Grace.

The judge heard testimony from each of us, including the children. She had some hard questions which were aimed at getting to the truth and we actually felt she represented the courts interests in this situation well. We felt she was careful but fair.

Today, we are waiting for the judges response. It is taking a long time to get the result but we are told it is likely to come before the end of March. As you can imagine the wait isn't welcome.

Joshua and Grace have now been part of our family for more than 5 years. This is longer than either of them had known any other life. Grace arrived at our home at 2 years old weighing 4.2kgs and unable to walk. She had no teeth and little hair and was suffering from serious malnutrition. Joshua was also malnourished but not as badly.

Since their arrival in our home, Joshua and Grace have transformed our lives. We love them so much and can't imagine a life without these two amazing individuals. We hope 2020 will see the adoption complete and allow them Canadian citizenship so we can travel home and introduce them to family and friends.

Education Must Be Good Business

In Uganda, there are 3 categories of schools. The Government schools are the ones no human wants to go to, they are attended only by those with no other option and are very badly spoken of by locals. International schools offer excellent facilities and school standards but are very highly priced and inaccessible to most families here (ours included). Finally, there is a huge number of privately operated schools. These are the schools most Ugandans attend and their standards vary widely.

As the Arise team plans and progresses a school solution for Uganda, it is these private schools who are the target of our solution. Our goal is not to compete with these schools, but rather to lead a revolution from within the pack. Uganda needs a revolution in the way it sees children and how it equips them. Our school must do more than improve government exam results. It must generate extraordinary youth and demonstrate to the educational community that educational excellence is good business.

Our goal is to make the business of educational excellence so financially appealing that schools are adopting these new methods as a business strategy. And once a critical mass of schools are bought-in, transformation will become inevitable.

Extraordinary youth taking their place as business people, politicians, teachers, and professionals of all kinds will create the necessary environment where real societal transformation may occur. In order to have the impact intended, this new breed of Ugandan school must:

- Provide Excellence in Education The school cannot just use memorized facts as the bar for success. It needs to ensure actual understanding for learners which will underpin real capacity as they enter the marketplace.
- Develop Integrity and Character The school must grow youth who will see the benefit in honest straight forward dealings with others and recognize corruption as being counterproductive to everyone economically and personally.
- Demonstrate Financial Profitability The school books must demonstrate that the tuitions of a school of excellence warrant the change of methods. Our school must become profitable and be ready to prove it to others.

Our purpose then is to create a school that can deliver on these three goals. This school will demonstrate 21st century educational methods and catalyze a revolution in the way children are educated.
